NOTICE REGARDING CLASS TEST OF SEM IV & VI (INTERNAL) MARCH-2022

All the students of SEM IV & VI are hereby informed that the online **Class Test of 10 Marks** each for all the four theory papers will be conducted on **Saturday 26th March, 2022** during **5.00 pm to 6.30pm**.

Note:-

1. This will be an online exam and the login ID and Password will be shared to all the students on their numbers registered in the college separately by the service provider. The students must appear for the exam through these Login credentials only.
2. Examination for each subject will be conducted for **10 MCQs for 10 Marks** and duration will be **20 Minutes** for each subject. Total duration will be 1 and half hour for complete exam of four subjects.
3. The students once logged in will see the four subject's name on the dash board and have to select the subject to appear for. When the subject is selected he will get the question paper for that subject and after attempting the question they should submit it. After submitting one paper again the subject is required to be selected, attempt and submit for all the subjects.
4. The complete exam shall be attended by a student in one login by submitting the all the papers after attempting them.
